

St Kuriakose Elias Chavara, the founder of the religious congregation, Carmelites of Mary Immaculate (CMI) is our role model and his vision is made manifest in our institution.

He has left an indelible mark in the spheres of education, social reform, media, culture and religious formation. India's first indigenous religious congregation for men, CMI was his brainchild. In 1831, along with the support of Fr Thomas Palackal and Fr Thomas Porukara, the CMI congregation was established which sparked off a spiritual renovation in the Church.

St Chavara established the first Catholic Sanskrit School in 1846. He also established seminaries for education and formation of the clergy, a publishing house, a home for the dying and the destitute as well as schools for general education. His claim "Education for All" led to the provision of education for girls as well as for people from all walks of life. He was a great educationist who used innovative ideas to mould an elite society. As a champion of social reform and a man who stood for integration, he has bequeathed us a legacy which we at Christ Nagar college proudly uphold.

History

The contributions made by the Carmelites of Mary Immaculate (CMI), the first indigenous Catholic Congregation of India, in the educational field of Kerala were pioneering and revolutionary. Saint Kuriakose Elias Chavara, the Founder of the CMI Congregation, established the first Catholic School of Kerala at Mannanam in 1846. All the other CMI Monasteries also followed that movement. In the year 1864, Blessed Chavara, in his capacity as the Vicar General of the Syro-Malabar Church, ordered all the parishes to start schools adjacent to them. This historic order triggered the emergence of a galaxy of educational institutions all over the state. It also became the basis of the socio-economic development of the whole state.

The main aim of the entire educational endeavour of the Congregation is to bring about a social transformation with emphasis on an option for the poor, coupled with the target of the moral reconstruction of the society. Today, the CMIs run about 500 educational institutions which include Schools, Arts and Science Colleges, Autonomous Colleges, M.Ed. and B.Ed. Colleges, Engineering Colleges, Polytechnic Colleges, IT centres, Nursing Schools, Research Centres and a Medical College.

About the College

Buoyed by the unstinting support extended by the public to Christ Nagar Group of Institutions, Christ Nagar College, a self financing institution, affiliated to the University of Kerala, Thiruvananthapuram, was established by CMI Fathers, the pioneers in the field of education and social reforms in the year 2012 at Maranalloor, a sleepy hamlet in Thiruvananthapuram District, just 12 km away from the city limits.

It is a premier institution set on a sprawling campus of 37.5 acres of land enveloped by the bounty of nature. Facilities

1. Classrooms

The classrooms are spacious with comfortable seating arrangements and are ICT enabled with Wi-Fi facility. All the classrooms and exam halls are under CCTV camera surveillance.

2. Library

The college library functions at the ground floor of the college building. The library has a collection of around 10,000 print books including reference books, journals, periodicals, newspapers and previous year University examination question papers. Computers are available in the library for online reference. Students can utilise the library facility during the lunch break, the library hours allotted to them and after the class hours. Facilities such as Reference and Information Service, New Arrival Display and Periodical Display are provided. The library's subscription to British Council Membership, enables students to access a wide variety of e-books, e-journals, e-magazines, e-newspapers, audio and video books. Additionally, the library provides facilities to access online resources like N-LIST. With computers and internet facilities in the library, users can make use of the online resources.

3. Lab facilities

Christ Nagar College has three fully functional computer labs, a Physics lab, a Media lab and a Psychology lab.

4. Computer Labs

As the college offers programmes like BCA, B.Sc. Mathematics, B.Sc. Statistics, B.Sc. Physics and Computer Applications, B.Com Commerce with Computer Application and M.Sc. Computer Science, 3 well-furnished computer labs, of which one is fully air-conditioned, are set up with modern equipped terminals. The computer labs offer around 200 computer systems and are loaded with the latest software and hardware. Two of the computer labs have two wall-mounted projectors, of which one is an interactive projector, utilised to take virtual classes. Each lab has

an LCD projector, high-speed internet service and LAN connectivity. Two servers from Dell PowerEdge are deployed to support the computers running Windows 10 and Linux operating systems. The firewall-SOPHOS is used to ensure network security. The labs are aided with power backup facility and are professionally set, using 200 Mbps Internet speed. The network connectivity has been extended to computer labs, the college library, classrooms, faculty rooms and office.

5. Physics Lab

The Department of Physics offers B.Sc. programme in Physics and Computer Applications. The department has a well-furnished and spacious laboratory with all experimental set up as prescribed by the University of Kerala according to the revised CBCS Syllabus. Each student can perform the experiments individually. The lab includes General Physics Lab, Optical Lab and Electronics Lab. A Nanomaterial lab is set up by the Department of Physics in association with the alumni, with the aim of the development of the research wing of the department.

6. Media Lab

A fully equipped Media Lab has been set up to facilitate a wide range of activities for students. This dedicated space primarily serves as a training ground for students pursuing Journalism. This includes a professional audio studio, a video shooting floor, and an editing suite.

The Drama Club of the college also utilises this facility to record dialogues, perform video editing tasks, carry out video shoots, and conduct audio recordings. This collaborative use of the media room enables students to engage in practical exercises while honing their skills in journalism and related fields.

These facilities ensure that students have access to the necessary resources for their creative endeavours such as music composition, short film production, and documentary making, Through this initiative, the college aims to nurture talent and encourage the exploration of various media production activities among our students.

7. Psychology Lab

The Psychology Lab is set up with all the facilities that could cater to the needs of students up to the research level. The facilities for psychological assessments, diagnostic tests and psychological experiments are arranged here.

8. Canteen/Cafeteria

The college has a well-furnished and spacious canteen with a seating capacity of 300. Nutritious and quality food is served here at reasonable and affordable rate. The food is prepared in hygienic conditions to ensure the health of the students. Apart from the college canteen, a food kiosk functions inside the campus which provides snacks and refreshments.

9. Boardroom

The Executive Boardroom features an air-conditioned conference room with an acoustic hard wood panelling, conference voice enhancement system and a wide choice of audio/video and presentation options. An interactive panel has been installed for conducting online classes. The room has a seating capacity of 40. The Boardroom is the venue for staff meetings, discussions and debates.

10. Theatre Room - Chavara Chamber

The capacious, air conditioned Theatre Room is the main venue for conducting international and national seminars and workshops. Students and teachers utilise the theatre for watching classic movies and for arranging ICT enabled programmes.

11. Seminar Halls

The college has two seminar halls. The seminar halls are spacious enough to accommodate about 300 students at a time. It is the venue for conducting PTA meetings, staff meetings, orientation programmes and other seminars.

12. Sports Complex

The college houses an Indoor Games Centre, seven courts and one cricket pitch. The Indoor Games Centre provides facilities for playing table tennis, carroms and chess. Outdoor games which include handball, basketball, football, badminton, cricket, kabaddi, kho-kho and volleyball are conducted at the college ground.

13. Auditorium & Open Stages

The college has a main auditorium with a spacious stage and a green room with all amenities. Two open stages with supporting audio-visual aids, lighting facilities and necessary equipment and properties are made available for hosting Cultural Fests of the college. Arts Day celebrations, College Annual Day celebrations and department wise association activities are also conducted here. College courtyard is a venue for activities like flash mobs, Freshers' Day celebrations etc.

14. Gymnasium

The gymnasium facilities are available separately for boys and girls. Modern and latest equipment are available at the gymnasium which can be made use of by the students after the class hours under the supervision of the physical education instructor. The gymnasium offers facilities like bench press, double twister, dumbbells and barbells.

15. Recovery Rooms

Separate recovery rooms are available for boys and girls adjacent to the departments. Students can rest in these rooms when they are sick.

16. Transportation

Transportation facility is provided to all the places in the city limit and to its suburbs from the college campus. At present, there are 12 buses plying on different routes to help students and staff reach the college on time.

17. Vending machine and incinerator

To maintain health and hygiene among the female students, a vending machine and incinerator have been installed.

18. Reprographic Room

The Reprographic Room offers facility for taking photostats. Students who need photostats should place order at the counter of the Reprographic Room during the break time. Stationery items which are necessary for the students are also available here.

19. Counselling Centre

Students can openly share their problems and worries with a professional counsellor in a confidential manner when they feel stressed, worried or depressed. Counselling facility is available on all working days. Online counselling facility for parents, staff and students is also arranged.

20. Placement and Career services

The Placement Cell of the college provides career guidance and arranges interviews with various companies for the students. The placement cell of our college actively obtains opportunities for our students to secure promising jobs in well established firms. It also conducts workshops for the students to enhance their job acquisition skills and thus preparing them to be familiar with the corporate culture.

21. Women's Recreation Room

A Women's Recreation Room has been set up to provide facilities for entertainment and recreation to female students.

22. Lift

A lift has been installed to make the campus disabled-friendly. The staff members, and the students who are sick make use of this facility.

23. Solar Power Plant

A 20 KW Solar Power plant under the KSEB scheme has been set up to tap solar energy and it reduces dependence on conventional sources of energy. In the near future, the Christ Nagar campus would become a completely green campus as all the energy needs would be met using solar power.

Admission Procedure

The college offers all the programmes under Self-financing category. Applications are invited at the beginning of each academic year. 50% seats are allotted on the basis of merit through online application by the University and 50% management quota seats through an interview based on the academic performance of students at the Higher Secondary / UG level and their achievements in the extra curricular activities. Application forms can be obtained online. Payment can be made through challan or net banking.

Eligibility

Eligibility for admissions and reservation of seats for various First Degree Programmes shall be according to the rules framed by the University of Kerala from time to time. No student shall be eligible for admission to a First Degree Programme in any of the discipline unless he/she has successfully completed the examination conducted by a Board/University at the Higher Secondary level of schooling or its equivalent.

Working days and College timing

Regular classes are held from Monday to Friday and the class timings are from 8:30 a.m. to 1:10 p.m. The college office is open from 8:00 a.m. to 4:00 p.m. from Monday to Friday and on Saturdays it will be from 9 a.m. to 2.30 p.m.

Issue of Certificates

Transfer Certificate

A student applying for the transfer certificate must have paid all fees and other dues to the college. If his/her application for such a certificate is not received within one year of leaving the college, he/she will be liable to pay a late fee along with the prescribed fees. If the original transfer certificate is lost, it will not be issued unless there is a certificate from an officer ordinarily not below the rank of the first class magistrate affirming that the TC has been lost irrecoverably.

Conduct Certificate

It is a document that the student has to earn. It will not be issued as a matter of course. All students are expected to engage in good behaviour and must follow the rules of the college.

Return of the Original Documents

Qualifying certificates submitted by the students on admission will be returned to them only at the completion of their respective university examination. SSLC book, mark lists, etc. have to be claimed at least within a year after leaving the college. The college office cannot be held responsible for any damage or loss to the certificate left unclaimed by the students.

Procedure for obtaining the submitted Documents for important purposes:

If the students want to get any certificates from the college to avail tax benefits, scholarships, fee concession or certificates to prove that they are bonafide students of the college, they must give an application one day before they need the certificate. The certificates must be returned within three days or it must be mentioned in the application (the date of return).

Campus Behaviour

Students are expected to have good and pleasing manners.

- 1) It is mandatory for all the undergraduate students to be in full uniform on all working days. On special days they will be permitted to wear colour dress.
- 2) Be gentle, clean and decorous in dress, decent in language and behaviour.
- 3) Be respectful to your teachers and other staff in the college.
- Do your best to preserve the peaceful academic atmosphere of the campus.
- 5) The campus is a non-smoking area.
- 6) Disfiguring college furniture, walls, doors and windows with drawings, engravings or posters, attempting to tamper with electrical installations etc. will be penalised.
- 7) Every student should attend the class regularly and punctually.
- 8) Students should also attend functions, and other co-curricular activities regularly and punctually.
- 9) Be in the class at the first bell. No student shall enter or leave the class without the permission of the teacher engaging the session. If anybody reaches the college after the prayer, enter only after meeting the Head of the concerned department.
- 10) Prayer is an invocation to God. The students should observe perfect silence at the time of the prayer.
- 11) Students are not supposed to loiter around the campus during class hours.
- 12) Students are allowed to receive visitors only with the permission of the Principal. Students are strictly prohibited from making any kind of communication to the outsiders who visit the campus.

- 13) Transact business in the college office in a polite and patient manner.
- 14) The medium of communication on the campus shall be English.
- 15) Students are not allowed to take mobile phones to the classrooms. Violation of this rule may result in confiscating such phones.
- 16) Always be courteous to the opposite sex.
- 17) Any form of violence, threat, intimidation and extortion that cause physical or psychological harm to a student shall be considered ragging. Students indulging in such behaviour shall be summarily expelled from the college.
- 18) Immediately after the admission a student receives an ID card. This card is to be worn on all the days to the college, and should be shown to the authorities on demand.
- 19) Students' vehicles are not permitted inside the college campus.
- 20) Students are prohibited from circulating any note or pasting it anywhere in the college, collecting money or organising any meeting without the permission of the Principal.
- 21) Make use of the dust bins kept in different parts of the campus.
- 22) If any student is found entering the campus after consuming alcoholic drinks or drugs, he/she will be expelled immediately, and action will be initiated for the removal of such a student from the college.
- 23) If any student wants to leave the campus early, he/she should produce a letter stating the reason from the parent and show it to the class teacher and get the out-pass from the Head of the concerned department with the seal from the college office. The name of the student and the time of leaving the campus must be recorded in the movement register kept at the office.
- 24) In the case of illness or any other physical problems also a student must follow the same procedure except submitting the letter from the parent in advance.

Behaviour in the Computer Lab

- 1) Computer labs are to be used only for academic purposes.
- Every student using computers must sign in on the lab log book. Remember to sign out after the use.
- 3) Students must not change, modify or update computer configurations.
- 4) Students are not allowed
 - to install or use any external software in the lab.
 - to move, change or replace any computer peripherals.
 - to bring food and drinks into the lab.
 - to use the lab resources or printers for personal use.
- 5) Viewing of pornographic or inappropriate materials is strictly prohibited and violation of this will be considered as serious indiscipline.

Library Rules

- 1) The library will be open from 8 a.m. to 4 p.m. on all regular working days & Saturdays.
- College ID card is compulsory for availing the services of the library. Each student will be given two library cards. Students can borrow books only if they produce the cards. Books will be issued after verifying the card.
- 3) Students at the UG level will be issued a maximum of 2 books, PG level 3 books, and faculty members five books.
- 4) A book is issued for 14 days. The same can be renewed unless the particular book is not demanded by another person.
- 5) Books borrowed from the library shall be returned within the due date.
- 6) A fine of Rs.1 /- per day will be levied if the library materials are not returned within the stipulated time. The fine must be paid immediately, until then the right to borrow books will be suspended.

- 7) Learning resources from the reference section will not be issued.
- 8) Reference books, periodicals, and journals must not be taken out of the library.
- 9) Strict silence must be observed in the library.
- 10) Bags and personal belongings must be kept outside the library.
- 11) Do not displace the library furniture.
- 12) Borrowers are responsible for the books marked against their names. In case of damage they shall pay the cost of replacement or binding.
- 13) Loss of books should be reported to the librarian immediately.
- 14) Any book lost or damaged must be replaced with the same or the latest edition.
- 15) No student shall lend his/her library books to a fellow-student or outsiders.
- 16) CDs are issued only for overnight use.
- 17) Reservation facility is available for books which are in high demand.
- 18) Students should not mark, underline, write, tear or damage the library books.
- 19) Students should return their library card to the librarian before they claim their TC.
- 20) Students must obtain no dues certificate after returning the borrowed books and paying all the dues (before the end of the programme).
- 21) Students are encouraged to utilise the online reading facilities.

Intercollegiate Competitions

Students are encouraged to participate in various intercollegiate competitions with proper preparation.

1) Students are not allowed to participate in any competition in the name of Christ Nagar College without the Principal's permission.

- 2) Prior permission should be sought from the Principal for practice.
- 3) Students are allowed to practise only during the allotted time.
- 4) The students should practise on the campus only under the supervision of a lecturer.
- 5) If any indiscipline or indecent behaviour is reported about any students during the time of practice, strict action will be taken against them.
- 6) Only one day class may be given for practice.
- 7) Make use of Saturdays and Sundays for practice.
- 8) All the expenses like the the registration fee, TA, etc. must be borne by the students themselves.

Rules regarding the use of conveyance facilities

- 1) Only the students who have bus pass can travel by the college bus.
- 2) Reach the boarding point at the correct time.
- 3) Students must travel only by the bus which is allotted to them.
- 4) Behave in a disciplined manner when you travel by the college bus.
- 5) You cannot play music, shout or talk loudly inside the bus that would divert the attention of the driver and cause disturbance to the students.
- 6) Limit the use of mobile phones inside the bus.
- 7) Taking photographs is strictly prohibited.
- 8) Nobody is supposed to change seats or walk to and fro when the bus is on the move.
- 9) Do not alight at any other stops/points other than your regular stop without getting prior permission from the Principal.
- 10) A fine will be levied, if you cause any damage to the seats, arm rest, glasses, doors or any part of the bus.
- 11) Heated discussions or arguments are not allowed inside the bus.
- 12) Only the students and staff of Christ Nagar College can make use of

the conveyance facility arranged by the college.

- 13) The bus fee must be remitted at the college office on the prescribed date.
- 14) All the rules which are applicable on the college campus are applicable when you travel by the college bus also.
- 15) If there is any change in your boarding point, Principal/Financial Administrator must be informed about it.
- 16) Do not stand anywhere near the open door when the bus is moving.
- 17) Make sure that the bus has stopped before you board the bus or alight from it.
- 18) You cannot play any games inside the bus.
- 19) Girls must occupy the front seats and boys the back ones.
- 20) Use of obscene language and indecent behaviour will be seriously dealt with.
- 21) The staff members who travel by the college bus have the full authority to control students if any kind of indisciplined behaviour is observed.

Rules regarding the use of Canteen facility

- 1) Students will not be allowed inside the canteen during class hours.
- 2) Keep the canteen and its premises clean.
- 3) Extravagance is not encouraged by the college authorities.
- 4) The college canteen is not a place where you can offer treats or arrange parties for your friends.
- 5) Do not waste food items.
- 6) You are not allowed to take food items out of the canteen to your classrooms.
- 7) Students are not allowed to bring food from outside to the college canteen.
- 8) Colour coded dustbins are placed in the canteen and in different

areas for disposal of different kinds of waste. The green, blue and yellow coloured dustbins are meant for biodegradable wastes, plastic and papers respectively.

Grounds for leave

- 1) Students are not encouraged to take leave or remain absent from the college without any valid reason.
- 2) However, in special circumstances, leave is granted as per University Rules. For this, written request from the parents is required.
- 3) In case of a medical leave, a certificate from a registered medical practitioner is to be submitted.
- 4) In urgent situations parents shall inform class teachers through phone.

Examination Rules

General Rules

- 1) Students should enter the examination hall before the second bell.
- 2) Students coming after the third bell should report to the teacher in charge of the examination.
- 3) Candidates will not be allowed to enter the examination hall if half an hour has passed since the commencement of the examination.
- 4) Students will not be allowed to remain in the examination hall after examination time.
- 5) Students are not allowed to leave the examination hall for any reason during the examination. If there is any case of medical emergency that may require the candidate to use the toilet, the college authorities should be informed before the examination.
- 6) The students should not write anything or make any marks on the question paper unless it is suggested by the college or the university.
- 7) Malpractice during any examination shall be severely dealt with.
- 8) Students must observe silence and strict discipline in the examination hall.
- 9) Mobile phone is strictly prohibited in the examination hall.
- 10) Students must present their ID cards to the invigilator before the examination.
- 11) Sharing of writing and drawing materials, statistical tables and calculators are not allowed.
- 12) Students should use the same ink for writing the whole examination.
- 13) On hearing the warning bell (5 minutes before the end of the examination) students must tie up their additional sheets properly along with the main sheet.

14) Students must keep all their belongings at a space specified for them by the invigilator. The college authorities do not take any responsibility for the loss or damage of such belongings.

Internal Examination Rules

- 1) Attending internal examinations is compulsory.
- 2) Malpractices will be strictly dealt with.
- 3) Students are allowed to leave the examination hall only 15 minutes before the end of the examination.
- 4) Re-examination will be conducted only in genuine cases.

University Examination Rules

- For University examinations, students must bring their hall tickets. Students shall not be allowed to write the exams without the hall ticket.
- 2) Students are not permitted to enter the examination hall after 30 minutes from the scheduled time of the examination.
- Students are supposed to leave the examination hall only 30 minutes before the end of the examination.
- 4) Violation of any rules of conduct of the examination will be viewed as a serious offence and will result in immediate cancellation/ disqualification. Any kind of malpractice can lead to suspension/expulsion of the candidate.
- 5) Any kind of malpractice would be referred to the University and may result in the student being debarred for a period of three years.
- 6) The hall tickets must be kept by the students till the completion of the programme.

Guidelines for the Payment of Fees

1. Semester Fees

1 (a). Parents and students are requested to make maximum use of

the online payment mode available in the college website for all kinds of fee payments.

1 (b). Semester fees must be paid within 15 days from the commencement of each semester (as intimated by the University of Kerala).

1 (c). First semester fees must be paid at the time of admission itself.

1 (d). In case of any extension of date required for fee payment, the parent of the concerned student should meet the Principal personally and give a request in writing.

1 (e). An extension of 15 days (maximum) may be given by the Principal in consultation with the Financial Administrator at the request of the parent.

1 (f). No dues certificate duly signed by the Principal must be submitted by the student to the concerned Head of the Department before the commencement of the first internal examination in all semesters.

2. Scholarship (Kuriakose Elias Young Student Support Scheme-KEYSSS)

2 (a). Students who are good at studies and are financially backward may avail Kuriakose Elias Young Student Support Scheme (KEYSSS).

2 (b). Deserving candidates after consulting the Manager may collect the scholarship request form from the college office and may fill the form completely before handing it over to the concerned class teacher.

2 (c). Class teacher and Head of the Department may approve/disapprove the request in consultation with the Principal and will forward the form to the Director/Manager.

2 (d). Manager/Director decides the scholarship amount in consultation with the Financial Administrator.

2 (e). Students who avail scholarship may continue to do the same procedure in every semester if she/he needs the scholarship

2 (f). Criteria for the scholarship: Annual income of the family, Academic performance of the student, Conduct and behaviour of the student in and outside the campus.

3. Exam Fees

3 (a). Exam fees may be paid as and when directed by the University of Kerala following the directions from the college office.

4. Transportation Fees

4 (a). College bus facility is an extra service provided by the college management and it will be on a first come first serve basis as there are only limited seats available.

4 (b). Students who need college bus facility should register at the college office in the prescribed form and get a bus pass from the office prior to the beginning of each academic year.

4 (c). A valid bus pass is compulsory for using the college bus facility and all students who use college bus facility should carry a valid bus pass while travelling by the college bus.

4 (d). Transportation fee must be paid for one academic year; not in instalments.

4 (e). If anybody is discontinuing the college bus facility, she/he must submit the request form properly signed by the parent for cancelling the same.

4 (f). Only from the day of submitting the cancellation form, the student's name may be removed from the list of the students using college bus facility.

4 (g). Only those who pay the bus fees before the prescribed date [as in 4 (b)] will be allowed to make use of the college bus facility.

4 **(h).** There will be changes in the college bus routes on exam days and other days when all classes do not have regular offline classes, which will be intimated in advance by the class teachers.

4 (i). In case of changing the boarding points, parents must meet the Principal/Financial Administrator in advance with a written request to get permission, based on the availability of seats in the new route.

The Following Activities are Banned on the

Dissociation of students from politics on the College Campus as per Supreme Court order SLP No. 24295/2004.

Prevention of Ragging.

Ragging is prohibited by law. It is a non-bailable criminal offence and punishable with rigorous imprisonment up to seven years. Students shall not indulge in any of the following activities, which are treated as ragging.

- 1) Any act that prevents, disrupts or disturbs the regular academic activity of a student.
- 2) Exploiting the service of a junior student by a senior student or a group of senior students.
- Any act of financial extortion or forceful expenditure burden put on a junior student including fund –raising for organisations.
- Any act of physical abuse including all variants of annoying, playing practical jokes, sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts or gestures.
- 5) Any act of abuse by spoken words, emails, SMS or any other means.

- 6) Any word or act that causes hurt to the dignity of the individual.
- 7) Entering without permission into any class other than the one assigned to a student.
- 8) Forcing a student to boycott class without his/her consent to participate in strike, demonstration, dharna etc.

The complaints or information in regard to ragging could be oral or written and even from third parties. The burden/responsibility of proving his/her innocence rests with the accused. Complaints can be lodged with the Principal, staff counsellors or any of the members of the Ragging Prevention Committee. All complaints/ information received shall be kept strictly confidential. In the event of a student being booked in a criminal offence and being suspended from the college he/she will be re-instated only after he/she obtains clearance certificate from the concerned police officer.

Established Centres for Student Development

Its primary objective is to establish dense, diverse, and rapidly growing forests within a relatively short period of time. This method involves planting a wide range of native tree species in close proximity within a small area, aiming to mimic the natural processes of a forest and promote accelerated growth.

At the Christ Nagar College campus, the Miyawaki technique has been implemented, incorporating a variety of trees and shrubs such as gooseberry, tamarind, cotton, laburnum, teak, and fig. With an impressive selection of 119 species, the forest at Christ Nagar boasts around 300 trees and plants.

The Miyawaki method operates on key principles including planting diverse species, incorporating multiple layers of vegetation, and maintaining close spacing between the trees. These forests provide numerous benefits to the local ecosystem, including the creation of habitats for various species, improvement of air and water quality, prevention of soil erosion, and the sequestration of carbon dioxide, which helps mitigate the impacts of climate change.

4. Entrepreneurship Development Club (ED Club)

Entrepreneurship Development Clubs are set up by the Department of Industries and Commerce, Government of Kerala, mainly with the objective of promoting the entrepreneurial traits among students in schools and colleges.
